

KENTUCKY CATTLEMEN'S ASSOCIATION HALL OF FAME AWARD RULES & NOMINATION FORM

PURPOSE OF AWARD

The Kentucky Cattlemen's Association Hall of Fame is designed to honor a member of the organization that has given time, service, and talent to the betterment of the Cattlemen's Association at the county and/or state levels.

SELECTION OF INDUCTEES

Five people will be inducted into the KCA Hall of Fame, with one inductee being from each of the Kentucky Cattlemen's Association Membership Regions. It is not mandatory that a person from each region be honored each year. Winners will be notified in early fall.

RECOGNITION OF AWARD

Hall of Fame Inductees will be recognized during the Kentucky Cattlemen's Association Convention Evening Extravaganza. Each recipient will receive two tickets to the banquet when the award will be presented.

SELECTION OF COMMITTEE

A committee of five is to utilize whatever method it desires to collect data and make its selection(s). The committee will serve for three years and then rotate off with a new group being selected. The committee will be comprised of industry representatives.

GUIDELINES FOR SELECTION

This program is designed to give appropriate recognition to those who have made highly significant achievements in agriculture or agribusiness. Honorees selected and recommended by the committee shall possess the following criteria: 1) have impeccable character; 2) have provided truly outstanding leadership affecting Kentucky agriculture 3) have made noteworthy contributions; 4) have received recognition for achievements; and 5) recognition should be given to nominees with great accomplishments.

NOMINEE ELIGIBILITY

- Nominated by his/her county association
- Been active and prominent in the work of their county association and/or the Kentucky Cattlemen's Association
- Nominee must be a current Kentucky Cattlemen's Association member
- No current member of the Kentucky Cattlemen's Association Executive Committee is eligible for nomination to the Hall of Fame.

APPLICATION REQUIREMENTS

- Complete nomination form (must be typed)
- Recommendation letter supporting nomination from county leader
- *All application materials must be submitted at once to be considered complete.
